This policy outlines the university's approach to integrating sustainable practices in urban development, community engagement, and partnerships to promote environmental, social, and economic well-being in the local and broader community.</p>
<p>Policy Scope</p>	<p>This policy applies to the university's engagement in urban development, community projects, outreach programs, partnerships with local governments and organizations, and any other activities that have the potential to impact local communities and urban environments.</p>

All university departments and units are responsible for:<ul style="list-style-type: none">• Integrating sustainability principles into their community engagement, research, and urban development activities.• Collaborating with the Office of Sustainability and external partners to achieve the objectives of this policy.3. All members of the university community are responsible for:<ul style="list-style-type: none">• Contributing to the university's efforts to promote sustainable cities and communities through their actions, research, and community engagement.
Policy Compliance	Non-compliance with this policy may be addressed through review and feedback mechanisms. The university is committed to fostering a supportive and collaborative environment for the implementation of sustainable practices in building cities and communities.
Policy Review	This policy will be reviewed and, if necessary, revised every year or as needed to ensure it remains relevant, reflects the latest standards and practices in sustainable urban development, and aligns with the university's goals and objectives.
