Purpose	The purpose of this policy is to outline AAU's commitment to reducing the environmental impact of plastic use on campus. This policy aims to minimize the consumption of single-use plastics, promote the use of sustainable alternatives, and ensure responsible plastic waste management, aligning with global efforts to address plastic pollution and promote environmental sustainability.
Scope	This policy applies to all university operations, including dining services, campus stores, events, and facilities management. It covers the procurement, use, disposal, and recycling of plastic materials within the university.
