Policy Scope	This policy applies to all university activities that involve	
	engagement with external communities, including academic	
	partnerships, research projects, service learning, volunteering,	
	outreach programs, and any other forms of community	
	collaboration.	
Policy Responsibilities	1. The Deanship of Students Affairs is responsible for:

	effective community engagement.	
	2. Academic and Administrative Departments are	
	responsible for:

	strategic goals for community engagement.	
	3. Faculty, Staff, and Students are responsible for:
