	habitats. This policy outlines the university's commitment to	
	integrating marine conservation into its research, education,	
	community engagement, and operational practices.	
Policy Scope	This policy applies to all university activities that directly or	
	indirectly impact marine environments, including academic	
	research, educational programs, community outreach,	
	procurement, and any other activities related to marine	
	ecosystems.	
Policy Responsibilities	1. The Office of Sustainability is responsible for:	
	<ul> <li>Coordinating the implementation of this policy.</li> </ul>	
	<ul> <li>Providing guidance and support to departments</li> </ul>	
	and units on integrating marine conservation	
	into their activities.	
	2. The Research Office is responsible for:

	marine conservation research and disseminating	
	findings to the wider community.	
	3. All university departments and units involved in	
	marine-related activities are responsible for:
